## OVERVIEW:

The New 42nd Street seeks a Director, Information Technology - Network Infrastructure & Security Operations who will be responsible for providing technical solutions to meet the organization's evolving needs. The Director, Information Technology - Network Infrastructure & Security Operations oversees the day to day operations to support New 42's technology stack, both on-premise and Cloud environment. This role is also responsible for researching and developing new technological initiatives, streamlining, automating, and simplifying IT processes, facilitating their implementation, educating staff to use technology effectively, and continuing to support and enhance these systems. This position will also serve as an advisor to senior management on essential strategic forecasting of future IT needs to identify emerging technologies and trends, develop new architectural directions, and support the continuous improvement of business functions.

This role will be hands-on, requiring an understanding of various technologies and an ability and willingness to learn new ones. Responsibilities include creating and managing an annual IT budget, coordinating software and hardware upgrades with departmental staff, and managing a wide range of software projects, large and small, to enhance and support the use of all company-wide systems. These systems and platforms include, G-Suite ecosystem, other cloud computing resources, productivity/collaboration tools, VOIP phone systems, Network and Security Devices.

## Qualifications:

- Bachelor's degree with ten years of IT experience minimum, along with three years of managerial experience. A Master's degree is highly preferred.
- Experience with on-premise and cloud-based strategic technology planning
- Experience with supporting architectural frameworks, processes, standards and guidelines related to systems, business or data architecture.
- Provide technical and architectural subject matter expertise to senior management including communicating technology decisions and mentoring other technical staff around the various technologies and decisions.
- Experience in creating and maintaining a Payment Card Industry Data Security Standard (PCI DSS) compliant environment, ability to document and maintain audit documentation/ life cycle.
